

FOR BRITISH AND WELSH CITIZENS - NEW ZEALAND New Zealand Government ETA Visa - NZeTA Visitor Visa Online Application - Visa Seland Newydd Ar-lein - Visa Swyddogol Llywodraeth Seland Newydd – NZETA.

Mae'r Awdurdod Teithio Electronig ar gyfer Seland Newydd NZETA yn awdurdodiad teithio electronig ar gyfer trigolion gwledydd hepgor fisa. Sefydlwyd yr NZeTA a anfonwyd yn y flwyddyn 2019. Mae'r Visa hwn yn gweithio'n union fel fisa mynediad. Mae'r hepgoriad NZeTA neu fisa yn orfodol ar gyfer yr holl deithwyr sy'n dod i mewn i Seland Newydd: Gall trigolion pob un o'r 60 o wledydd hepgor fisa ddod ar daith Awyren.



Gall dinasyddion 191 o wledydd ddod ar long fordaith. Mae Awdurdod Teithio Electronig Seland Newydd mor syml fel y gallwch ei gwblhau'n gyfan gwbl ar y rhyngwyd, a derbyn eVisa trwy e-bost. Mae NZETA yn caniatáu i ddinasyddion cymwys groesi ffin Seland Newydd at ddibenion twristiaeth, busnes neu deithio heb fynd trwy'r broblem [Newzealand Visa Application Online](#) sefyll yn y ciw neu aros i'r pasbort gael ei stampio. Nid oes angen postio na negesydd i unrhyw un o swyddfeydd y llywodraeth i gael ETA Seland Newydd. Ar hyn o bryd mae'n ofyniad gorfodol ar gyfer hepgor fisa cenedlaethol, yn ogystal â theithwyr llongau mordaith o bob gwlad. Mae angen yr ETA NZ hyd yn oed ar Drigolion Parhaol Awstralia.

Gall dinasyddion cymwys wneud cais trwy gais syml Awdurdod Teithio Electronig Seland Newydd ar y we ar gyfer twristiaeth, ymweliad busnes neu gludo i wlad arall o Faes Awyr Rhyngwladol Auckland. Disgwylir i ymgeiswyr lenwi ffurflen gais Awdurdod Teithio Electronig Seland Newydd gyda manylion unigol ac adnabod. Mae gan Fisa Seland Newydd y gofynion canlynol, sicrhewch fod gan basbort dudalen wag fel y gall staff mewnfudo ei stampio ar y maes awyr. Hefyd, dylai eich pasbort fod yn ddilys am 6 mis ar adeg mynediad yn Seland Newydd. Mae'r dinasyddion canlynol yn gymwys i wneud cais am Fisa Ar-lein Seland Newydd neu NZeTA, Lwcsembwrg, Ffrainc, Cyprus, Sbaen, Portiwgal, Iwerddon, Gwlad Pwyl, Sweden, Hwngari, Awstria, Bwlgaria, Denmarc, Malta, Slofenia, Slofacia, Latfia, yr Iseldiroedd, Tsiec , yr Almaen, Gwlad Groeg, Estonia, Romania, yr Eidal, Gwlad Belg, Croatia, y Deyrnas Unedig, y Ffindir a dinasyddion Lithwania.

The Electronic Travel Authority for New Zealand NZETA is an electronic travel authorisation for residents of visa waiver countries. The NZeTA sent was established in the year 2019, this Visa works exactly like an entry visa. The NZeTA or visa waiver is mandatory for the all inbound travellers entering New Zealand: Residents of each of the 60 visa waiver countries can come by Airplane tour. Citizens of 191 countries can come by cruise ship. Electronic Travel Authority New Zealand is so simple that you can complete it entirely on the internet, and receive eVisa by email.

NZETA permits qualified citizens to cross the border of New Zealand for the tourism, business, or travel purposes without going through the problem of standing in the queue or waiting for the passport to be stamped. No postage or courier to any [Newzealand Visa Application](#) government office is required to obtain New Zealand ETA. It is presently a mandatory requirement for visa waiver national, as well as cruise ship travelers of all countries. Even the Permanent Residents of Australia are required the NZ ETA. Qualified citizens can apply through the straightforward

New Zealand Electronic Travel Authority application on the web for tourism, business visit or transit to another country from Auckland International Airport. Applicants are expected to fill in the New Zealand Electronic Travel Authority application form with individual and identification details. New Zealand Visa has the following requirements, ensure passport has blank page so that immigration staff can stamp it on the airport. Also, your passport should be valid for 6 months at the time of entry in New Zealand. The following citizens are eligible to apply for New Zealand Visa Online or NZeTA, Luxembourg, France, Cyprus, Spain, Portugal, Ireland, Poland, Sweden, Hungary, Austria, Bulgaria, Denmark, Malta, Slovenia, Slovakia, Latvia, Netherlands, Czech, Germany, Greece, Estonia, Romania, Italy, Belgium, Croatia, United Kingdom, Finland and Lithuania citizens.
